Staffing

 - They assumed duty on 3rd April 2018.

- The Steering Committee appointed Mr. Taiwo Joda, MD/CEO of Accion MfB as Acting CEO of MLDC, providing leadership and supervision for its staff.
- Ongoing are the institutionalization and adoption of policies to operationalize MLDC's activities, leveraging AFOS existing structure.
 - Necessary work tools have been approved by the Acting CEO for staff.
 - Monthly management meeting have been setup for periodic review of team activities.



MLDC Operations (contd.)

The dual functions of the MLDC team are as follows:

- Coordination of all <u>capacity building initiatives</u> and <u>training activities</u> to be driven by Head of Training, supported by the NMP Coordinator.
- The <u>Secretariat functions</u> and all <u>Platform activities</u> will be driven by the NM Platform Coordinator, also supported by the Head of Training.



AFOS/MLDC Partnership Agreement

The team have started implementing the AFOS-MLDC Agreement through the:

- Organisation and coordination of <u>AFOS Microsave trainings</u>, which earned MLDC the agreed percentage as handling fees in April 2018.
 - These trainings were held in Lagos and Abuja with participants from LAPO, ACCION, HASAL and FORTIS.
- Coordination of the NM Platform Secretariat is now being actively done by the Coordinator.
- Initiated the discussion around the planned Agric Sector trainings expected to start with 30,000 smallholders' farmer trainings later in 2018 till 2020. The Agric sector training agreement is pending signoff during the strategy retreat slated for 1st and 2nd June 2018 in Lagos.

- Initiated Pension registration process with PENCOM through Stanbic IBTC Pension Managers limited.
- Draft strategic plan document is up for discussion at the upcoming retreat of 2nd June 2018.
